- 1. Call to Order and Attendance
 - a Meeting called to order at 2:00pm.
 - b Commissioners Jeanne Galloway, Greg Lewis, and Carolyn Ness in attendance.
 - c PVMCD Coordinator Chris Craig in attendance.
- 2. Public Comment/Output
 - a No public comment.
- 3. 2021 Mosquito Surveillance Reports
 - Chris presented commissioners with drafts of the 2021 surveillance reports before their submission to member boards of health.

 Commissioners suggested including narrative remarks regarding the findings throughout the season for the reports.
- 4. SRB Call Recap
 - a Jeanne and Chris detailed discussions with SRB members to discuss the needs of the PVMCD going forward. Primarily, the need for the acquisition of work space was the first priority to grow the district's service capacity and continue being able to accept new members. The potential acquisition of funds from the ARP for these needs were discussed.
- 5. Review of Potential PVMCD Facilities

- a Chris provided examples of adequate facilities for the PVMCD. Suitable industrial spaces of 5,000 to 10,000 square feet are primarily concentrated in Hampden county around I-91 in Holyoke, Springfield, and West Springfield.
- 6. Vacant Commissioner Position Discussion
 - a The search for a new commissioner for the vacant position was discussed. There were no applicants for the position since the October meeting.
 - b Jeanne requested that commissioners continue to reach out to potential candidates that may want to apply.
